**BUILDING PERMIT FEES NOT COVERED BY THE WISCONSIN UNIFORM DWELLING CODE: Remodeling and/or new construction in excess of \$1,000 (under County zoning)**

Application for a Town Building Permit under the Wisconsin Uniform Dwelling Code shall be made to the Town through the Building Inspector. The above building permit and inspection fees shall be paid to the Town of Brillion and collected by the Building Inspector. No permit shall be issued until the appropriate fees have been paid in full.

All other building permits, those not covered by the Wisconsin Uniform Dwelling Code, shall be obtained from the Town Chairperson or from the Calumet County Planning Department. These fees shall be paid to Calumet Planning Department. No permit shall be issued until the appropriate fees have been paid in full.
