TOWN OF BRILLION Calumet County, Wisconsin Application for Permit to Display Fireworks

1. Per Wis. Stat. 167.10(3) (c), the following may obtain a permit: public authority, fair association, amusement park, park board, civic organization, any individual or group of individuals, an agricultural producer for the protection of crops from birds or animals.

2. The following penalties are enforced through Wis. Stat. 167.10:

a. A person who possesses or uses fireworks without a valid permit, or who sells fireworks to a person who does not have a valid permit, is subject to a forfeiture of up to \$1,000 per violation.

b. A parent or guardian who allows a minor to possess or use fireworks (not including those for which no permits are required) is subject to a forfeiture of up to \$1,000 per violation and legal costs.

c. A city, village or town may obtain an injunction prohibiting a person from violating Wis. Stat. 167.10
(8) (a) regarding the sale, use, storage and handling of fireworks. Violations of such an injunction are criminal misdemeanors, subject to up to 9 months in jail and a \$10,000 fine.

3. Long-term storage of fireworks requires that they be located at least 500 feet from a dwelling, public assembly or place where gasoline or other volatile liquids are sold or stored. The Fire Chief shall be notified in writing of the storage location.

4. EVEN WITH A PERMIT, NO FIREWORKS USAGE IS ALLOWED WHEN THE FIRE DANGER LEVEL IS "VERY HIGH" OR "EXTREME". Users are financially responsible for any property damage or any costs incurred for a response from the Fire Department or DNR, no matter what the Fire Danger level is. Call 888-WIS-BURN (947-2876) to check the DNR status.

5. It is recommended that fire extinguishers be on the premises and easily accessible.

6. It is recommended that permit holders review Wis. Statute 167.10 regarding fireworks (viewable online at: docs.legis.wisconsin.gov/statutes/statutes/167/10).

Applications must be received by the Town of Brillion no later than 10 days prior to the requested date of use. Cost of the fireworks permit is \$20.00.
